DIRECTIONS FOR USE: Mix one part of concentrate to 20 parts water or 50 mL concentrate per litre of water. Spray on overgrown surfaces, wetting thoroughly. Suggested dosage: up to 550 mL spray solution per square metre surface. For best results avoid applying during rain or snow. Repeat treatment annually, or at onset of recolonization.

NOTE: Moss and algae sprayed during the growing season discolour within days. Growth sprayed in the dormant (cold) season may discolour over a longer period.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Causes eye irritation. Avoid eye contact. May cause skin irritation. Do not apply to foliage of plants, shrubs or trees. Also treated surfaces may be temporarily slippery. Do not contaminate productive bodies of water.

FIRST AID: In case of eye contact, flush with water for 15 minutes. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.
