### Rate Recommendations

#### FOLIAR APPLICATIONS

**Turf:** For professional use only, apply 3-6 fl oz per 1,000 sq ft monthly or as needed to maintain color and vigor.

**Fairways, Lawns, Athletic Fields and other Turf Areas:** Apply 4-8 quarts per acre (3-6 fl oz per 1,000 sq ft). Three to four applications per growing season are recommended to maintain healthy, vigorous turf.

**Ornamental Shrubs:** Mix 1 gallon in 100 gallons of water and spray foliage thoroughly to point of runoff. For larger shrubs and trees, apply 2 fl oz (4 tbsp) per inch of trunk diameter in sufficient water for through coverage. Make 2-4 applications at monthly intervals during the growing season to help maintain plant color and vigor.

Best results will occur when applied to actively growing foliage during periods of high humidity and low plant stress (early morning, late afternoon, cloudy days are preferable to hot, dry conditions).

#### SOIL APPLICATIONS

Apply 4-8 quarts per acre.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

### Mixing and Handling Instructions

Apply in a minimum of 10 gallons water per acre or 3 gallons water per 1000 sq ft. This product may also be applied via drip or sprinkler fertigation. Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rains are expected. Apply this product only to your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
