4. FIRST AID MEASURES

Eye Contact	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media

Specific hazards arising from the chemical

6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment, and emergency procedures

Personal Precautions	Use dust mask and gloves as needed or other reasonable personal protective equipment as required to prevent contact with eyes or skin. Remove ignition sources prior to clean-up. If experiencing significant respiratory symptoms: seek medical attention.
Environmental precautions	Prevent entry into waterways, sewers, basements or confined areas. Do not flush into surface water or sanitary sewer system. See Section 12 for additional ecological information.
Methods for containment	Prevent further leakage or spillage, if safe to do so.
Methods for clean-up	Use dust mask and/or reasonable personal protective equipment as required to avoid breathing dusts. Moisten or cover powder spill with plastic sheet or tarp to minimize spreading. Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust.
