DIRECTIONS FOR USE

Apply only as directed.

Use Andersons Nutri DG[®] Dispersing Granule Technology 12-24-8 for greens and tees where a nitrogen, phosphate and potassium application is desired or when micronutrients are needed to help correct or prevent deficiencies during the growing season.

Watering in this product will disperse each granule into thousands of particles. This will facilitate the movement of the nutrients into the soil. This particle dispersion will greatly reduce ball, shoe and mower pickup - minimizing nutrient loss.

Application to wet, close-cut golf turf may result in foliar staining, which will discolor the turf to a brown/black appearance. This will occur even if immediate irrigation or rainfall occurs. Be sure to apply this product to dry turf only.

Application Rates:

1.53 - 3.05 kg/100 m² (3.13 - 6.25 lbs/1,000 sq. ft.)

Apply at the rate for the amount of Phosphate desired.

For all applications:
