## RATE RECOMMENDATIONS FOR PROFESSIONAL USE ONLY

To prevent or correct nutrient deficiencies, apply GRIGG BURLEY GREEN as a liquid spray early in the morning or late afternoon to reduce drift. Allow 3-6 hours for drying time before irrigation. For best results, apply after mowing when temperatures in the root zone exceed 50°F and environmental conditions favor turf growth.

**Foliar and Soil Applications:** Apply as needed every 21-28 days.

**Cool Season Grasses:** Apply 6-9 fl oz per 1000 sq ft or 2-3 gal per acre [20-30 L per hectare].

**Warm Season Grasses:** Apply 9-15 fl oz per 1000 sq ft or 3-5 gal per acre [30-50 L per hectare].

Make frequent applications at lower rates, or apply higher rates at times of greater plant demand. Optimum rate of application will vary depending on treatment interval, soil properties (such as pH, organic matter content, texture), weather conditions, time of year, plant species and its nutrient requirements. For best results, follow soil/tissue test recommendation.

## MIXING AND HANDLING INSTRUCTIONS

Agitate before use. For foliar and soil applications, apply in a minimum of 2 gal of water per 1000 sq ft (88 gal of water per acre) [800 L of water per hectare]. For soil applications, apply light irrigation following application for best results. Fill mix tank with half of required water volume and begin agitation. Add products in this order, mixing thoroughly after each addition: adjuvants, pesticides, then fertilizers. Fill tank with remainder of water and continue agitation until solution is completely mixed. Check chemical mixture compatibility using a jar test prior to application.
